



BRIDGE MAINTAINER
Dutchess County Department of Public Works
Salary: \$ 41,837 (2020 Salary)

This is a non-competitive position in the Dutchess County Department of Public Works. This class performs varied duties in connection with the construction and maintenance of bridges. The work calls for previous experience in the carpentry and masonry fields but does not require the skills of a qualified journeyman. Verbal or written instructions regarding the work are received from the Bridge Maintenance Supervisor who checks jobs in process and on completion.

TYPICAL WORK ACTIVITIES:

Participates in the construction and repair of bridges, culverts and bridge approaches; constructs wooden forms for concrete work related to bridge maintenance and construction; participates in the pouring of concrete for footings, abutments, docks, etc.; participates in the placing and finishing of concrete; assists in general maintenance work during certain times of the year on the interior of buildings; assists in other carpentry activities such as repairing small buildings or sheds; occasionally assists in highway maintenance and construction projects; participates in snow and ice control activities. may be required to operate a gang truck in the transporting of men and equipment between job sites; does related work as required.

MINIMUM QUALIFICATIONS:

One year of experience in construction which included carpentry and/or masonry work.

SPECIAL REQUIREMENT:

Candidates must possess a valid New York State Class B Commercial driver's license permit at time of application. They must obtain the Class B license within six months of appointment and maintain such license while in the title. This license must contain no restrictions other than those relating to personal physical conditions. Such restrictions will be reviewed on a case by case basis for compatibility with job duties and will not be an automatic bar to employment. A copy of the current valid license/permit is required at time of application to be able to be considered for appointment.

SPECIAL NOTE: Applicants for positions that require driving a commercial motor vehicle (CMV) at any time will be required to undergo controlled substances and at our discretion, alcohol testing prior to employment and will be subject to further testing throughout their period of employment. Applicants will also be asked to sign forms for release of information from previous employers in all cases where driving a CMV was one of your functions. Failure to sign will prevent this employer from using you as a CMV driver.

FINGERPRINTING: A fingerprint supported background investigation is required before an appointment is made to some positions. Pursuant to New York State Executive Law, the Division of Criminal Justice Services requires that a fee accompany each such request for a search. It is due once a job offer is made and accepted by the applicant.
